Executive Summary

As the COVID-19 pandemic necessitated all businesses to pivot their normal operations to protect customers and employees, Anne Arundel County responded by working with Anne Arundel Economic Development Corporation (AAEDC) to create a Customer and Employee Protection (CEP) Grant Program. As County Executive Steuart Pittman recognized, "We can step in to help small local businesses meet the challenges they face in protecting both their customers and their employees from COVID-19. This program not only helps our small businesses to reopen safely, but it allows them to implement best practices that will serve the future public health needs of our county."

Funded by the federal Coronavirus Aid, Relief, and Economic Security (CARES) Act and subsequent funding allocated to Anne Arundel County, a little over five million dollars was allocated to the program to help county businesses purchase and/or be reimbursed for personal protection equipment (PPE), protective shields, dividers, digital signage, graphics, technology upgrades, consultation services, delivery vehicles, and workforce training. Grantees were awarded up to \$10,000 based on actual budgeted items and/or receipts for eligible purchases. Companies located in Anne Arundel County with fifty or less employees and that are in good standing with the State of Maryland were eligible for the grants.

The AAEDC CEP Grant Program accepted applications from June 3rd through July 24th, 2020. During that period, AAEDC processed 961 applications and awarded 788 grants totaling a little over five million dollars. The average grant amount was \$6,370.83. Of the 788 grants awarded, 171 were to companies in the City of Annapolis and totaled approximately \$1.12 million.

Minority-owned businesses accounted for 26% of the dollars allocated; woman-owned businesses accounted for 44%; and veteran-owned businesses accounted for 5%. Nonprofits received 9% of the total funds in the program.

While the awarding of grants was to businesses throughout Anne Arundel County, the majority of the recipients were from the central and western portions of the county. This roughly coincides with where the highest concentrations of businesses are.


The majority of the grants awarded were for planned expenses. Applicants were required to submit a budget of items they had purchased or would purchase, if they were to be awarded the grant. Fifty-seven percent of those awarded grants were for expenses businesses planned to make to pivot their operations in response to COVID-19. Reimbursements for purchases already made accounted for 23% and the remainder were for a mixture of both.

Applicants were asked to identify their business by industry. The largest industry category that received grants was "Other Services", but we expect that may be due to business owners not being clear as to what industry their business is in from the choices given. "Other Services" was followed closely by "Education and Health Services" and "Leisure and Hospitality". These three industry categories accounted for 80% of the grants awarded.

In conclusion, the AAEDC CEP Grant Program was highly successful in helping these Anne Arundel County businesses pivot to protect both customers and employees from COVID-19.









Distribution by County Council District




By Legislative District




Distribution by Legislative District
