








The real property tax base breakdown provides insight as to what percentage of total assessed real property tax revenue is attributed to commercial properties. The remainder is attributed to either residential or agricultural properties. This is useful in determining where the burden of property taxes exist in a geographic area. In Anne Arundel County, 22.33% of the total assessed value of residential and commercial properties comes from businesses, while 77.06% of that total is collected from homeowners.

Commuting Patterns—Anne Arundel County

After examining the most recent data from the U.S. Census Bureau's Center for Economic Studies, Anne Arundel Economic Development Corporation found that the number of noncounty residents who enter the county to work is nearly identical to the number of Anne Arundel County residents who leave the county to work.


Inflow/Outflow Job Counts

62.9% work outside the county (144,393)




37.4% of Anne Arundel County residents work in the county

Where Anne Arundel County Workers Live

The U.S. Census Bureau's commuting patterns data shows where those who hold primary jobs in Anne Arundel County live. Approximately 62.6% (142,489) of those working in Anne Arundel County commute from nearby counties, with the most popular outside sources of workers including Baltimore County (12.3%), Prince George's County (8%), Baltimore City (7.8%), Howard County (6.5%), and Montgomery County (4.6%).

Inflow Job Counts



Where Anne Arundel County Residents Work

The U.S. Census Bureau's commuting patterns data shows that 37.4% (85,168) of Anne Arundel County residents hold primary jobs in Anne Arundel County. For the remaining 62.9% (144,393), the top five most popular destinations for work are Prince George's County (10.9%), Baltimore City (10.4%), Howard County (9.5%), Baltimore County (9%), and Montgomery County (6.2%). Approximately 5.9% of Anne Arundel County residents commute to Washington D.C for their primary job (does not include many federal civilian government employees excluded for national security reasons).
